1. This consent form of adoptive parents is required when minor adopted person submits "Petition for Adoption Information Disclosure" according to Special Adoption Act article 36.

2. When adoptive parents request adoption information disclosure of applicant(minor adopted person), adoptive parents(legal representative) must submit the following documents:

① 1 copy of "Petition for Adoption Information Disclosure" which applicant (minor adopted person) person has drafted (Attached Form No.16)

② 1 copy of document to show that applicant(minor adopted person) expressed his/her intention to request adoption information disclosure

③ 1 copy of Identification card which verifies the age of applicant (minor adopted person)

④ 1 copy of a document which certifies family relations of adopted person and legal representatives
