- ① 1 copy of "Petition for Adoption Information Disclosure" which applicant (minor adopted person) person has drafted (Attached Form No.16)
- ② 1 copy of document to show that applicant(minor adopted person) expressed his/her intention to request adoption information disclosure
- 3 1 copy of Identification card which verifies the age of applicant (minor adopted person)
- 4 1 copy of a document which certifies family relations of adopted person and legal representatives
